Dear prospective Consultants,

Please find below our answer to the clarification request submitted under this procurement procedure by one of the companies interested in these services. This clarification complement/supplement, if it is the case, the Terms of References as issued.

With reference to the consulting service **02/QBS/2017**, please clarify the following:

Question no. 1: "...expert in communication with at least 5 years of relevant experience in preparing user-friendly information materials (and other communication tools) for farmers". It is requested that the diploma should be in journalism/communication or equivalent. Can it be understood sociology/psychology, also?

Answer no. 1: Yes, it can be understood sociology/psychology, also.

Question no. 2: "...full-time local farm advisers / trainers / facilitators, each with at least 5 years of experience in the provision of practical, on-farm advice to farmers". It is requested that the diploma should be in journalism/communication or equivalent. Taking into account the specific of the counselling for the farmers, the expert degree can be in agronomy or agricultural sciences, also? Or in sociology/psychology, also?

Answer no. 2: Yes, the degree can be in agronomy or agricultural sciences and also sociology/psychology.

Question no. 3: "...expert in communication with farmers with at least 5 years of experience on information dissemination towards farmers, including via web-platforms, email, phone etc". It is requested that the diploma should be in journalism/communication or equivalent. Taking into account the specific of the counselling for the farmers, the expert degree can be in agronomy or agricultural sciences, also? Or in sociology/psychology, also?

Answer no. 3: Yes, the degree can be in *agronomy or agricultural sciences* but also in *sociology/psychology*.

Question no. 4: “...expert in farm advisory techniques or communication between farmers with at least 5 years of experience, including good knowledge and experience of the principles and practice of planning / running Farmer Discussion Groups / Interactive Demonstration of Good Farm Practices at farm site”. It is requested that the diploma should be in *journalism/communication or equivalent*. Taking into account the specific of farm advisory, the expert degree can be in *agronomy or agricultural sciences, also? Or in sociology/psychology, also?*

Answer no. 4: For the position mentioned above, the degree in *sociology/ psychology* cannot be accepted, but the degree can be in *agronomy or agricultural sciences*.


