- (i) The **Government of Romania** has received financing from the World Bank toward the cost of the **Integrated Nutrient Pollution Control Project- Additional Financing**. The overall development objective of the Project is to support the Government of Romania to meet the EU Nitrates Directive requirements by reducing nutrient discharges to water bodies, promoting behavioural change at the communal level and strengthening institutional and regulatory capacity. The Government of Romania intends to apply part of the proceeds toward payments under the contracts for equipment.
