Following publication of the Request for Expression of Interest for the assignment - 03/LCS/2020, The Client received the following requests for clarifications. Consultants will consider the following responses to their requests for clarifications as becoming part of the Terms of References and will take them into consideration when preparing their Expressions of Interests and their proposals.

**Request for clarification:**

With regard to the Request for Expressions of Interest - 03/LCS/2020

We would like to know whether site supervision engineers certified for works under Domain 3.2 **Roads-bridges** (but not certified under domain 2.1), are acceptable and could be assigned for site supervision services for some of the platforms.

We would like to mention the platform from Jucu comuna, Cluj county, where the State Inspectorate of Construction requested a site supervision engineer certified in the roads Domain.

**Answer:**

As it is mentioned in the Terms of References, chapter 6. Consultant's Profile and estimated level of effort, the Supervision Consultant shall assign site supervision engineers, for each investment (or "(...) *in case execution of works at certain investments is carried out during different time periods or the investments are in close vicinity, the same supervision engineer may be assigned for more than one investment.*"), having Site Supervision Certification for Civil, Industrial and Agricultural constructions - Domain 2.1.

Also, at least other two site supervision engineers having Site Supervision Certification for **Domain 3.2. (Roads, bridges, tunnels, aviation tracks, cable transport)** or higher will be assigned to all investments.

In conclusion, it is not acceptable to assign site supervision engineers (diriginti de santier) certified **only** under Domain 3.2 or higher, for the supervision of the works execution of the platforms in the list of investments subject to the requested services. The site supervision engineers (diriginti de santier) assigned for the supervision of the works execution of the platforms must be certified under Domain 2.1. Besides these experts, the Consultant will ALSO have to provide at least other two site supervision engineers certified under domain 3.2 or higher who will be assigned to all investments.
